## **WORLDVIEW AND IDEOLOGICAL BASIS**

### REPUBLICAN PLATFORM – A COMMON GOAL FOR THOSE WHO CARE

#### OUR VALUES

**I. Ukrainocentrism** is the perception of events through the prism of Ukrainian identity for the sake of the Ukrainian national interest, which is a combination of national interests of Ukraine as a state, interests of Ukrainian citizens and Ukrainians in the world.

Goals and tasks of Ukrainocentrism:

1. Ukraine (its territory, civil society, state institutions) is free, powerful, and prosperous.
2. Ukrainian space (which is not limited by the territory and fully represented in the state) is spiritual, safe, cultural, and informative.
3. The Ukrainian economy is competitive in the world, self-sufficient, stable, and modern.

#### **II. Republicanism:**

- Freedom of those who are responsible. You should not belong to another person, and at the same time, you do not have the right to do everything you want. A person has to be responsible for himself or herself, his/her family and country;
- Civic valor. The common good is more important than the personal one.
- Equal participation of those who care in defining common rules of life, in joint actions and access to power.
- A worthy evaluation of the importance and value of everyone's contribution to the state or other common cause.

### **III. The rules of life:**

1. **Fair:** righteous laws; equal opportunities; transparent and responsible government.
2. **Just:** people get what they deserve; no one is above the law; everyone gets a fair trial.
3. **Efficient:** protection of citizens; self-realization for everyone; development of the country.

### **THE RULES OF LIFE**

It is the primary responsibility of the authorities to develop and keep fair rules of life. Such rules are the key to self-realization of the citizen, which is the basis of economic prosperity and competitiveness of the state.

#### **I. ECONOMIC RULES**

*THE PRINCIPLES of economic rules:*

- common sense, efficiency
- simple ways to start a business, tax and fee motivation for entrepreneurs
- equality of the participants within one economic sphere or group (self-employment, small, medium, large business)
- elimination of all possible corruption components
- positive competition and demonopolization
- partnership with the state and local authorities
- Obligation to follow the rules by the state, local authorities, and all economic entities

*THE QUALITIES of economic rules:*

- honesty
- transparency
- certainty and predictability of current prospect
- protection by the law and state institutions

- simplicity and accessibility

## **II. SOCIAL RULES**

### *THE PRINCIPLES of social rules:*

- the government, for which the national interests are more important than personal ones; it is ready for sacrifice, self-restraint, and self-control
- righteous laws
- fair treatment of everyone, regardless of rank and position
- opportunities for self-realization of the person
- minimizing all bureaucratic obstacles and procedures
- taking into account the worldview values and national traditions
- dialogue and partnership between society and government
- following the rules by all branches of state and local authorities, citizens and public institutions

### *THE QUALITIES of social rules:*

- publicity and work transparency of the authorities, as well as public institutions and organizations
- perception of the rules by the majority of society
- minimal state intervention in citizens' personal life
- certainty and predictability of the future.
